

Legislative Update

- **HB 1573** (*New Title*) making an appropriation to the department of health and human services to enhance oversight of children in residential placements. This bill, originally titled AN ACT relative to oversight of and criteria for residential placement of children, originally passed out of the policy committee 15-0 and passed the House on a voice vote on February 22, 2024. House Finance amended it to strip out all of the policy and simply left the statement of findings and \$1million in unencumbered funds to DHHS, adding a Floor Amendment to at least require reporting on the use of those funds. It will be heard in Senate Judiciary on April 23.
- **SB 417** *relative to out-of-home placements for children* passed through the Senate (Judiciary & Finance) with some amendment, and a large fiscal note including 12 new positions. It will be heard in House C&FL on April 23.
- **SB 459**, originally an Act relative to the presumption of harm under the child protection act, contained a number of important amendments to the definitions in RSA 169-C, relating to abuse, neglect, serious impairment and the presumptions of harm, which are sunsetting July 1, 2024. DHHS introduced a fiscal note containing 35 new positions, totally \$1.6million. The Senate amended the bill to become a study committee. It will be heard in House C&FL on April 23.
- SB 572 relative to establishing a committee to study the sharing of confidential records among members of a multidisciplinary child protection team has passed both the Senate & House.





Restraints & Seclusion Incidents Reported to the OCA from Residential Facilities Rolling 12 Month: 4/01/23 – 3/31/24




Restraint & Seclusion Explanation

- This data includes all residential facilities which the OCA receives restraint and seclusion reports from.
- The OCA only receives restraint and seclusion reports from contracted facilities; we do not receive them for certified-only facilities, including many of the out-of-state facilities beyond the New England region.
- Although we have made multiple attempts to receive ALL restraint and seclusion reports via the DCYF reporting email, they have been unsuccessful, so we will be sending a letter to each residential facility certified by the State to inform on our statute and the reporting we need to begin receiving regularly.





Hampstead Hospital & East Acres Explanation

- The OCA is still NOT receiving any restraint or seclusion reports from East Acres or Hampstead Hospital. An email was sent to the CEO on March 14, 2024, requesting that we begin receiving them regularly. The OCA is currently receiving aggregate data from Hampstead Hospital, but without the narrative reports of specific incidents to review we are unable to accurately assess the use of restraint and seclusion in the program, nor can we fully review or adequately respond to complaints to our office about specific incidents.
